General Guidelines

To be considered for the scholarship, you must:

- Graduate in May 2024 from a Yuma County High School or enrolled/transfer student from AWC
- Have a minimum of 3.00 cumulative grade point average
- Be admitted to ASU
- Attend ASU in the Fall 2024 as an incoming Freshman enrolled in at least 12 credits
